INSTRUCTIONS FOR A NAME CHANGE FOR A MINOR

A. Obtain Relevant Documents

1. You will need to get legible copies of the minor's birth certificate and any court ordered judgment of custody.

B. Complete the Petition for Name Change of a Minor

- 1. Both parents must sign the petition.
- 2. The verification pages must be notarized by the submitting parents.
- 3. We cannot you legal advice. If a parent cannot or will not sign the petition, you will need to contact a private attorney for additional assistance.

C. Deliver Your Petition

- 1. First, submit your Petition for Name Change and copies of the relevant documents to the District Attorney's Office to answer.
- 2. Next, once it is approved by the District Attorney's Office, you can then submit your Petition to the District Court for approval.
- 3. Finally, after your Petition for Name Change is approved by the District Court Judge, all signed documents will need to be submitted to the Clerk of Court (337) 437-3550, along with the check or money order for the filing fee. (You will need to contact the Clerk of Court to find out how much it will cost to file it.). Be sure to get enough certified copies to provide to the various entities that you want to inform of your new name, such as Vital Records, School Board, etc.
